

CONSENT TO THE PROCESSING OF PERSONAL DATA ON THE WEBSITE

As a user of the web pages of the website located on the Internet at: <https://1home.az>, providing access to the database of goods and services offered through the specified services (hereinafter referred to as the User and the Company, respectively), freely, voluntarily, and in my own interest, I give LLC "1HOME BAKU," N°(TIN) 2009045201, specific, comprehensive, informed, conscious, and unambiguous consent to the processing of the following information related to my personal data:

- Full name;
- Passport details;
- Residential registration address;
- Phone number;
- Information about my email address;
- Technical data, including (but not limited to) IP address, metadata, cookie data, cookie identifiers, information about the browser and operating system, mobile device identifier;
- Banking details;
- Other information provided by me to the Company.

The processing of personal data may be carried out using automation tools or without them, as well as through a combination of both automated and manual processing methods.

In accordance with the Law of the Republic of Azerbaijan dated May 11, 2010, No. 998-IIIQ "On Personal Data" (as amended and supplemented as of 28.06.2024), the term "processing of personal data" refers to actions (operations) involving personal data of individuals, including collection, systematization, accumulation, storage, clarification (updating, modification), use, transfer (distribution, provision, access), anonymization, blocking, deletion, and destruction.

The purpose of personal data processing:

- Registration on the Company's website.
- Storage, placement, and other processing of data by the Company and third parties, including the use of cloud storage.
- Execution and fulfillment of orders, including delivery and order status control.
- Use of services provided by the Company and/or third parties.
- Notifications about new products, promotions, discounts, orders, product availability, as well as notifications, requests, and information related to the use of the Company's website, including communication with the User.
- Promotion of goods, works, and services in the market through direct contact using communication tools such as phone calls, mobile network communication, chats, SMS messaging, instant messaging services, email, push notifications, and other methods, provided consent to receive advertisements has been expressed.

- Ensuring participation in promotions and/or other marketing events.
- Conducting surveys, statistical, and marketing research, including research aimed at improving the quality of services provided by the Company.
- Conducting audits and other internal research, processing statistical data to improve the quality of services provided by the Company.
- Resolving claims.
- Enhancing the Company's website, correcting errors, and improving functionality.
- Identifying security threats to the Company's website and/or third parties, including verifying the reliability of the User when entering into agreements using the website. Creating data information systems, analyzing, modeling, forecasting, building mathematical models, profiling, targeting, constructing scoring models, their use, and transferring information processing results to third parties. Enrichment and segmentation to develop and adapt possible services and offers by the Company, analyzing aggregated and anonymous data, and for statistical and research purposes.
- Other purposes explicitly stated in agreements concluded between me and the Company for the provision of services or in other documents.

I am informed that:

- Consent for the processing of personal data can be withdrawn by me by contacting via email at info@1home.az.
- In the event of withdrawal of consent for the processing of personal data, the Company retains the right to continue processing it if there are grounds specified in the Law of the Republic of Azerbaijan dated May 11, 2010, № 998-IIIQ "On Personal Data" (with amendments and additions as of June 28, 2024), including storing personal data for the purpose of fulfilling the terms of any agreements concluded between me and the Company.

The Company undertakes not to transfer acquired personal data to third parties, except in the following cases:

- At the request of authorized state bodies of the Republic of Azerbaijan, strictly based on the grounds and procedures established by the legislation of the Republic of Azerbaijan.
- To strategic partners who work with the Company to provide goods and services or assist the Company in delivering goods and services to Users. The Company provides third parties with the minimum amount of personal data necessary solely for rendering the required service or conducting the necessary transaction.

The Company reserves the right to make unilateral changes to these rules, provided that the changes do not contradict the current legislation of the Republic of Azerbaijan. The changes to the terms of these rules come into force after their publication on the website.

The Company processes the User's personal data throughout the validity period of agreements and contracts concluded with the Company, as well as throughout the entire period of using the website, but no longer than five years from the date of the last use of the website or fulfillment of the last order, whichever occurs later.

Consent to the processing of personal data remains valid indefinitely until it is replaced by a new version.

THE COMPANY MAY USE INDUSTRY-WIDE TECHNOLOGY KNOWN AS "COOKIES"

Cookies are small pieces of data sent by a web server and stored on the User's computer, allowing the Company to save the User's personal settings and preferences, as well as collect non-personal information about them.

The User consents to the transfer of their personal data to the Company and third parties as part of necessary actions in accordance with the User's request on the Company's website, or similar execution of an agreement between the User and the Company, as well as for audit purposes.

The Company takes necessary and sufficient organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as other unlawful actions by third parties.

Consent is granted from the moment this document is signed and remains valid for five years. Upon expiration of the specified period, the consent is considered renewed for each subsequent five-year term in the absence of information regarding its withdrawal.

Consent for the processing of personal data may be withdrawn at any time by sending a written notice via email to info@1home.az.

Personal data will be deleted within 30 calendar days from the moment such notification is received.

Providing consent is expressed by clicking the "understood" button in the relevant pop-up window.
